**Note:**

- 1 Leadership in Energy and Environmental Design (LEED) is a program by U. S. Green Building Council (USGBC) that is a recognized standard for "Green" buildings. LEED incorporated the design and construction of the entire building envelope, of which the roofing system is a key part. LEED certification is earned based on meeting the specified energy and environmental criteria. Projects are awarded Certified (40 to 49 points), Silver (50 to 59 points), Gold (60-79 points), or Platinum (80 to 110 points) certification based on the number of credits earned. While six categories deal with LEED design criteria, several Tarco products qualify for LEED points based on "Materials and Resources" category.
- 2 To qualify under MR Credit 4.1, recycled materials should constitute at least 10% of the total value of the materials used at the project. One point is awarded.
- 3 To qualify under MR Credit 4.2, recycled materials should constitute at least 20% of the total value of the materials used at the project. Two points are awarded.
- 4 To qualify under MR Credit 5.1, a minimum of 10% of the materials, based on cost, used at the project must have been manufactured within 500 miles of the project site. One point is awarded under this category.
- 5 To qualify under MR Credit 5.2, a minimum of 20% of the materials, based on cost, used at the project must have been manufactured within 500 miles of the project site. Two points are awarded under this category.
- 6 It is important to note that roofing constitutes only a part of the whole building envelope, and Tarco products may be used only as part of the entire roofing assembly.
